Supporting documentation must demonstrate the securities description, purchase date, and investment total for each additional transaction you claim.

**Please refer to the Notice of Proposed Settlement of Class Action, Sections 7 and 12, before submitting additional documentation. Not all purchases of Metropolitan and Summit securities are covered by the Class.**
